Parent Responsibility

By enrolling a child at Bright Path Autism Academy, parents/guardians agree to honor the financial obligations of the school fees. Parents experiencing financial difficulty must communicate with school management in writing.

Billing Schedule

At the end of each term, parents will receive an invoice for the following term.

Parents may pay using one of the following options:

1. Full Payment

Full fees payable on or before the first day of the new term.

2. Installment Plan

Available upon written request and signed agreement:

- 50% before term opens
- 25% by the end of Month 1
- 25% by mid-Month 2

Withdrawal Policy

One full academic term's written notice is required when withdrawing a learner. Failure to give notice will result in payment of one full term's tuition in lieu of notice.

Mode of Payment

Payments can be made via:

- Bank Deposit / Transfer
- Mobile Money (Paybill details to be provided by the school office)
